Florida Education Finance Program (FEFP), Section 1011.62(1)(o), F.S.

- Weighted FTE included in the FEFP
- Calculation is <u>completed by the Department of</u> <u>Education</u> based on reported data elements



FEFP – Allocation and Expenditure Requirements for funds received from this calculation

- s. 1011.62(1)(o), F.S.
- Each district must allocate at least 80 percent of the funds provided for industry certification, in accordance with this paragraph, to the program that generated the funds.
- This allocation may not be used to supplant funds provided for basic operation of the program.



FEFP – Allocation and Expenditure Requirements for funds received from this calculation (Teacher Bonuses)

- Districts are required to pay bonuses to each classroom teacher who provided direct instruction toward the attainment of an industry certification that qualified for additional full-time equivalent membership.
 - Bonuses are awarded to teachers who are employed by the district in the year in which the additional FTE membership calculation is included in the calculation
 - Districts must determine which teachers qualify for the teacher bonus under the statute.



FEFP – Allocation and Expenditure Requirements for funds received from this calculation (Teacher Bonuses)

 The following bonuses are required from the funds in the 2017-18 FEFP Calculation:

Funding Weight on the 16-17 ICFL	Required Teacher Bonus in 2017-18	
0.1 Weight	\$25	
0.2 Weight	\$50	
0.3 Weight	\$75	
0.5 Weight	\$100	
1.0 Weight	\$100	

Governor Scott recently signed HB 7069 which removes the cap for teacher bonuses.



FEFP (Teacher Bonuses) – Additional Compensation Type Elements

- Teacher bonus information must be recorded in the Staff Information System
 - Additional Compensation Type element (Code 4)
 - Recorded on Surveys 2 and 3 for scheduled bonuses
 - Additional Compensation Type/Value element (Code 4 followed by 7-digit bonus figure which includes two decimal places)
 - Recorded on Survey 5 for paid bonuses
 - Example: \$450.00 = 40045000

Career-Themed Courses, s. 1003.493(1)(b)

- Career-themed course (CTC) is a course, or a course in a series of courses, that leads to an industry certification identified on the CAPE Industry Certification Funding List.
- Students earning industry certifications in careerthemed courses may generate additional FTE membership.
 - Required for CAPE Innovation Courses and CAPE Acceleration Industry Certifications
 - NOT required for CAPE Digital Tool Certificates and CAPE Innovation Courses
- Districts register CTCs which are summarized in Appendix FF.

Test Administration Procedures



Test Administration Procedures

- To report industry certifications, the following procedures must be followed for all written examinations:
 - Exam is not proctored by the individual providing the direct instruction for the industry certification or certificate, except under extremely limited conditions.
 - If only one individual is approved by the certifying agency as a proctor, the teacher may proctor the exams and must be independently monitored by a second individual who does not provide direct instruction for the industry certification content to the individuals taking the test(s).
 - Exam questions are delivered in a secure manner and paper-based tests are not available to the proctor for an extended period of time.
 - Exam is scored by certifying agency (cannot be scored by anyone at the district).
 - Exam is administered in accordance with the certifying agency procedures.
 - Exam must not have been administered more than 3 times during the academic year with a minimum of 20 days between test administrations.



Test Administration Procedures

- It is the district's responsibility to track the number of days between test administrations and the total test administrations.
- Certification exams administered that do NOT adhere to the required test administration procedures cannot be reported to the state for funding or any other purpose.
 - Includes certifications invalidated by the certifying agency
- For non-CAPE Assessments, Licensures and Certifications, districts must adhere to the same test administration requirements in 2017-18.

Industry Certifications Earned through Dual Enrollment

- In certain circumstances, industry certifications earned through dual enrollment will be included in the FEFP calculation.
- A new element on location of dual enrollment was added to the 2016-17 Industry Certification format to collect information required for certifications earned through dual enrollment.



2016-17 New Data Element – Dual Enrollment Institution Type

- This element will be used to determine whether a certification earned through dual enrollment is fundable in the 2017-18 FEFP.
- Districts will identify the type of postsecondary institution with which the dual enrollment occurred:
 - District Career Center/Charter Technical Career Center
 - Florida College System Institution
 - Nonpublic postsecondary institution



Dual Enrollment Funding Eligibility – 2016-17

Type of Dual Enrollment	Funding Criteria
District Postsecondary Center/College	 Certification is not on the CAPE Postsecondary Industry Certification Funding List (PSICFL) or is not funding eligible on the PSICFL for district performance funding Dual Enrollment Career-themed Course is registered (SCNS Course)
Florida College System Institution	 Certification is not on the PSICFL or is not funding eligible for colleges on the PSICFL Dual Enrollment Career-themed Course is registered (SCNS Course)
Private Postsecondary	 Dual Enrollment Career-themed Course for a private institution

- All CAPE Industry Certifications and CAPE Acceleration Industry Certifications reported must be linked to a course number
 - See the Industry Certification Reporting format for specific edits
- Districts must report on all certifications taken



- Data on CAPE Industry Certifications of students enrolled in dual enrollment courses must be reported if a certification was attempted.
 - This format cannot be used to report postsecondary dual enrollment course information for students who did not earn an industry certification.
 - Reminder: Dual enrollment students may be funded in the FEFP under certain circumstances.



- An industry certification code should only be reported with the <u>final</u> student outcome on the certification for the year.
 - The Industry Certification format allows a certification code to be reported with more than one course.
 - Even if the certification code is reported with more than one course, the funding calculation is unduplicated.



- Certifications are reported in the year that they were earned.
- Certifications may be reported linked to a prior year course in limited circumstances. Districts may report certifications earned during the prior reporting year, in cases where the certification could not have been earned by the end of the update period. This method cannot be used to correct data reporting errors.
 - Example: Student had to be 18 to earn the certification and the 18th birthday fell after the standard update period.
 - District may report prior year by using the following elements:
 - School Year Record Submission element equals current reporting year.
 - School Year Course Taken element equals the prior year.



- For a student earning an industry certification in a prior year (value of "P" on industry certification outcome), the student must not be reported with that same industry certification identifier in a subsequent reporting year.
 - For example, ADOBE010 This certification often has software updates and new versions of the software and subsequent exams are released. If a student earned the ADOBE010 certification in 2015-16, the student may not be reported as attempting or earning that industry certification in any following year.



- For certifications with work experience requirements, an industry certification identifier may be reported as an attempt when all exams have been taken and any requirements other than work experience are satisfied (i.e., report valid identifier on Industry Certification Identifier element and outcome of "F" on the Industry Certification Outcome element).
 - Students must not be reported with an "F" for two consecutive years if the only certification requirement outstanding is the work experience.



CAPE Digital Tool Certificates Reporting Guideline #1

- Data on CAPE Digital Tool certificates is reported on the Industry Certification format, Survey 5
- Limited to elementary and middle grades students (grades K-8)
- Elementary students' activity is reported with course number "0000000"
- Middle grades students taught in a course setting should be reported with a course number
 - If the digital tool instruction cannot be linked to a particular course, "0000000" may be used for the course number



CAPE Digital Tool Certificates Reporting Guideline #2

- Prior year reporting is <u>not allowed</u> for CAPE Digital Tool certificates
- Students who earn additional FTE membership for a CAPE Digital Tool certificate may not use the previously funded examination to satisfy the requirements for earning a CAPE Industry Certification (s. 1011.62(1)(o), F.S.).
 - Ex: MICRO801 (MOS Excel) may not be used toward the MICRO069 bundle

Background Information and Resource Information



Q. How long after a course is completed may a district report industry certification outcomes of students?

- School districts may report students who complete industry certifications during the update period allowed by the FDOE for Survey 5 after an initial submission. The survey period dates are approved and published on an annual basis. For example, in the 2016-17 reporting cycle, Survey 5 will close on February 23, 2017.
- Amendment period for 2017-18 reporting is much shorter



- Q. Does a district have to report data on students who take industry certification examinations, but who do not successfully earn the certification?
- Yes. Districts must report on all students who attempt to earn an industry certification. There are separate data elements for industry certification identifier and industry certification outcome with multiple values on the outcome data element to reflect the student performance on the examination.



- Q. A student is administered the same industry certification written exam on May 1 and does not pass. A re-test is administered on May 10 and the student earns the certification. Can this student be reported as earning the certification to the state?
- No. The test administration procedures were not followed. All certifications and certificates on the Industry Certification format must be reported in accordance with the test administration procedures.



- Q. A student is administered an industry certification exam three times and passed on the third attempt. Are all attempts reported on the Industry Certification format?
- No. For multiple attempts, only the final outcome for the year should be reported.



Q. How are elementary and middle grades students who earn a CAPE Digital Tool Certificate reported to the FDOE?

- Similar to CAPE Industry Certifications, districts must report certificates attempted or earned in Survey 5 on the Industry Certification format. However, there are some differences in the requirements. For these certificates, the following rules apply to reporting:
 - Can only be reported for students in grades K-8
 - For a student with a grade level of K-5, all zeroes must be reported for the course number
 - For a student with a grade level of 6-8, report the course number if the attainment of that certificate can be linked to the instruction provided in that course; otherwise, all zeroes may be reported for the course number.
 - Prior year reporting is not allowed for CAPE Digital Tool Certificates

- Q. If a middle grades student earns a CAPE Digital Tool Certificate that is also part of an exam bundle, can the Digital Tool exam be used toward attainment of another industry certification?
- No. Middle grades student who earn additional FTE membership for a CAPE Digital Tool certificate may not use the previously funded examination to satisfy the requirements for earning a CAPE Industry Certification. Example: A middle grades student earns Microsoft Office Specialist: Excel (MICRO801). That exam may not be used and funded as part of the MOS bundle (MICRO069).



Q. How are career-themed courses offered by school districts registered with the FDOE?

- The registration process for career-themed courses is specified in Rule 6A-6.0573(10), F.A.C.
- Registered courses are posted in Appendix FF, which can be found at:
 - http://www.fldoe.org/accountability/data-sys/database-manualsupdates/2016-17-student-info-system/index.stml#APPENDICES
- Career-themed courses are registered during the following windows:
 - Initial: October 16 to November 30 of the reporting year
 - Updates: February 1 to March 1 and August 1-10
- As part of this registration process, superintendents are required to certify the registered career-themed course meets all of the requirements in the law.



Reporting CAPE Innovation Courses



CAPE Innovation Courses Reporting Guideline #1

- Student enrollment
 - Reported on the Student Course Schedule format, Surveys 2 and 3
- Student performance
 - Reported on the Industry Certification format, Survey 5
- CAPE Innovation Course number must be reported with a single industry certification code for all courses - CAPEI001



CAPE Innovation Courses Reporting Guideline #2

- Districts need to report on all outcomes even if a student did not take the Advanced Placement assessment and/or the Industry Certification assessment.
- On the Industry Certification format, the code that will be used by the department to generate this funding is value "P" on the "Industry Certification Outcome" data element
