SESIR Key Features

- Developed 1995 for school staff
- Based on criminal code but not identical
- 26 incident categories reported
- Each incident may have related elements:
alcohol, bullying, drug, gang, hate-crime, hazing, injury or weapon

SESIR Incidents

- On school grounds, school transportation, or at off-campus school sponsored events
- The most serious offense (reported as Incident, Type) is the primary SESIR incident. Secondary offenses can be reported as one or more “**related elements**”.
- 365 days/24 hours
- Student, Non-Student or Unknown Offenders

SESIR Reporting

- SESIR incidents are per incident. Report only ONE incident even when there are multiple students involved in the same incident.
- Discipline actions are per student.

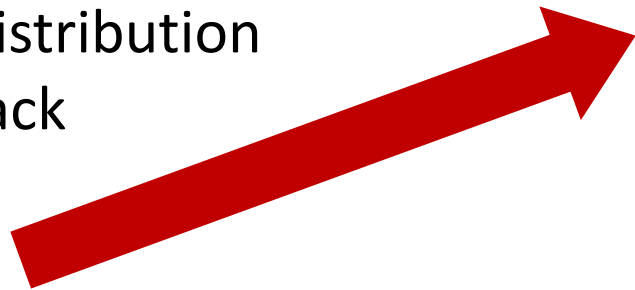

Changes to SESIR in SB 7030

- SESIR will be included in the Centralized Integrated Data Repository - *Florida Schools Safety Portal (FSSP)*. (s. 1001.212(6)(f), F.S.)
- OSS is required to ensure compliance with SESIR reporting requirements. (s. 1001.212(8), F.S.)
- Charter schools are required to comply with SESIR reporting requirements. (s. 1002.33(16)(b)10, F.S.)
- School Safety Specialists are required to review their district's SESIR reporting for compliance. (s. 1006.07(6)(a)1., F.S.)

Changes to SESIR in SB 7030 *(continued)*

- School boards must adopt policies for SESIR reporting. (s. 1006.07(9), F.S.)
- Superintendents are subject to penalties for non-compliance with SESIR reporting requirements, including withholding of their salary. (ss. 1001.212(8), 1006.07(9), F.S.)

Common problems with district data...

- Student-involved SESIR incidents with no matching disciplinary record.
- Schools reporting few/no SESIR incidents, but high discipline numbers or no discipline numbers (many charter schools)
- WPO firearms with no expulsion
- Districts reporting few/no Bullying incidents
- Not reporting School-Related Arrest
- Not or incorrectly reporting “Unsubstantiated” incidents
- UBL and UHR with matching discipline
- “Unknown offender” with a matching discipline record

What Does Accurate SESIR and Discipline Data Depend On?

- Knowledge of SESIR Definitions
- Software System design to optimize accuracy
- School Data Review/Correction
- Process for Entering Incidents & Disciplinary Actions
- Student Referral Screen/Form Design

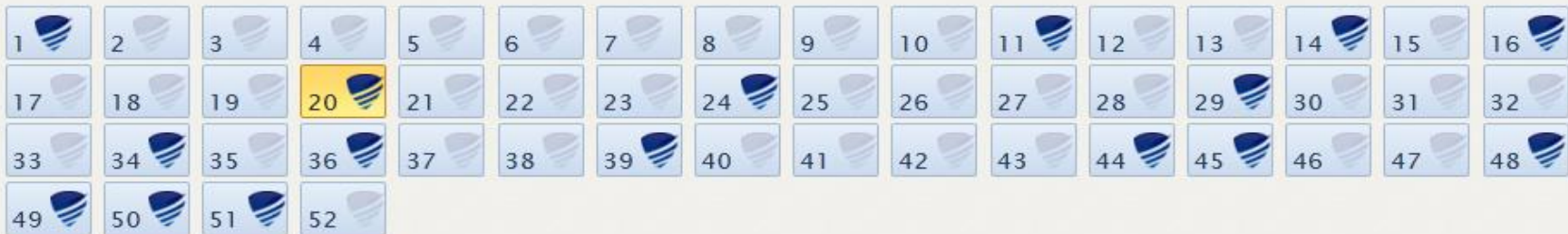

School Environmental Safety Incident Reporting (SESIR)

Codes and Definitions

The following SESIR definitions were developed to enable school districts to correctly code data used to report incidents that are against the law or represent serious breaches of the code of student conduct. This includes those incidents considered severe enough to require the involvement of a School Resource Officer (SRO) or incidents to be "Reported to Law Enforcement." The following definitions are not meant to match the Uniform Crime Report, nor are they intended to be an additional reporting system for law enforcement. When interpreting student behavior for SESIR reporting, consideration should be given to both developmental age-appropriate behavior and to those students with an Individual Educational Plan (IEP) or a 504 Plan.

Key

* Violent Incidents that must be reported in the data element "[Injury-Related](#)"

Violent Incidents if they Result in Bodily Harm that must be reported in the data element "[Injury-Related](#)"

Incidents that must be reported to SESIR and are expected to include consultation with Law Enforcement

Alcohol (ALC) - Level IV

(possession, use, or sale) Possession, sale, purchase, or use of alcoholic beverages. Use means the person is caught in the act of using, admits to use or is discovered to have used in the course of an investigation.

Arson (ARS) - Level I

(intentionally setting a fire on school property) To damage or cause to be damaged, by fire or explosion, any dwelling, structure, or conveyance, whether occupied or not, or its contents.

* Battery (BAT) - Level I

(physical attack/harm) The physical use of force or violence by an individual against another. The attack must be serious enough to warrant consulting law enforcement and result in more serious bodily injury. (To distinguish from Fighting, report an incident as Battery only when the force or violence is carried out against a person who is not fighting back.)

Breaking and Entering/Burglary (BRK) - Level II

(illegal entry into a facility) Unlawful entry with force, or unauthorized presence in a building or other structure or conveyance with evidence of the intent to damage or remove property or harm a person(s).

Disruption on Campus-Major (DOC) - Level III
