#### **COVID-19 Updates for CAPE Reporting**



#### Re-testing of K-12 Students on exams to earn Industry Certifications and Digital Tool Certificates

- Rule 6A-6.0573(13), F.A.C., specifies the test administration reporting procedures for industry certification and certificate exams. It includes a provision that limits administration to 3 times during the academic year with a minimum of 20 calendar days between exam administrations.
- This requirement is waived for exam administrations associated with 2019-20 enrollment.
- All other test administration procedures must be followed, including any re-testing requirements of the certifying agency.



#### At Home Testing for Industry Certification Exams- Secondary Only

Under the following conditions, students may be authorized to take an industry certification at home through remote testing.

The certifying agency for a credential:

- 1. Issues the same credential that would have been earned in their traditional proctoring situations,
- Has processes that ensure confirmation of student test taker's identity,
- 3. Ensures electronic versions of the exam are delivered securely,
- 4. Monitors the test administration remotely through a virtual proctor; and,
- 5. Implements a process for identifying testing irregularities.

#### **Appendix FF – Registered Career-themed Courses**

- Courses Registered by the School District during the open submission windows
- Career-themed course (CTC) is a course, or a course in a series of courses, that leads to an industry certification identified on the CAPE Industry Certification Funding List.
- Certifications earned in these courses may be eligible for the additional FTE calculation in the FEFP
- Fields
  - District Number/Name
  - School Number/Name
  - Course Number/Name
  - Indicator of Dual Enrollment Course Number
  - Certifications associated with the registered CTC

- Outcomes for CAPE Innovation Courses
- Any other technical skill attainment assessment for Perkins accountability measures on Appendix Z



#### **CAPE Course Reporting Requirements**

Report the course number in which the student attempted or earned an industry certification. Course numbers may be reported for Digital Tool Certificates, but are not required.

## Special Note on reporting <u>Dual Enrollment Courses</u> on the Industry Certification format

- Report only if a certification was attempted in the course.
- This format cannot be used to report postsecondary dual enrollment course information for students who did not attempt an industry certification.
- Dual enrollment students may be funded in the FEFP under certain circumstances; the certification cannot be fundable in another postsecondary appropriation.



#### Element for Identifying Dual Enrollment Funding Eligibility – Dual Enrollment Institution Type

- This element is used to determine whether a certification earned through dual enrollment is fundable.
- Districts will identify the type of postsecondary institution with which the dual enrollment occurred:
  - District Career Center/Charter Technical Career Center
  - Florida College System Institution
  - Nonpublic postsecondary institution
  - State university



#### **Reporting Outcomes**

- Data Element: Industry Certification Outcome
- The <u>final student outcome</u> should be reported for an industry certification.
  - If a student took the industry certification more than once, only the outcome of the final attempt should be reported.
- Codes for Industry Certification and CAPE Digital Tool Certificates:
  - P = Earned Certification/Certificate
  - F = Attempted but did not earn Certification/Certificate



#### Reporting Outcomes cont.

- Certification Code: CAPEI001
- Districts report on all outcomes even if a student did not take the Advanced Placement assessment and/or the Industry Certification assessment.
- CAPE Innovation Courses Funding Eligibility:
  - P = Student passed all assessments (academic and certification) for the course

#### When to Report an Outcome

- Certifications are reported in the year that they were earned.
- Reporting linked to a prior year course is allowed for certain industry certifications
  - Those for which there is a gap between when the student completes the course and when they can sit for the industry certification exam.
  - District may report prior year by using the following elements:
    - School Year Record Submission element equals current reporting year.
    - School Year Course Taken element equals the prior year.
  - In 2019-20, the DOE will be limiting the prior year reporting to certain certification codes.



#### **Reporting Industry Certification Date Earned**

- Beginning with 2018-19, an industry certification earned date is required.
  - http://www.fldoe.org/core/fileparse.php/18758/urlt/19 20-197290.pdf
  - If a certification requires multiple exams which may be taken on different dates, the industry certification earned date is based on the date of the examination which resulted in the award of the credential.



## Reporting Outcomes When Work Experience is Required

- An industry certification identifier may be reported as an attempt when all exams have been taken and any requirements other than work experience are satisfied (i.e., report valid identifier on Industry Certification Identifier element and outcome of "F" on the Industry Certification Outcome element).
  - Students should not be reported with an "F" for two consecutive years if the only certification requirement outstanding is the work experience.



#### **Special Note about CAPE Digital Tool Certificates**

- Prior year reporting is <u>not allowed</u> for CAPE Digital Tool certificates
- Students who earn additional FTE membership for a CAPE Digital Tool certificate may not use the previously funded examination to satisfy the requirements for earning a CAPE Industry Certification (s. 1011.62(1)(o), F.S.).
  - Ex: MICRO803 (MOS PowerPoint) may not be used toward the MICRO069 bundle or the MICRO017 Microsoft Office Specialist Master Certification.



### **FEFP Funding Issues**



## Florida Education Finance Program (FEFP), Section 1011.62(1)(o), F.S.

- The FEFP calculation includes additional FTE membership for certifications/certificates earned on the CAPE Industry Certification Funding List or for CAPE Innovation Courses.
- See Appendix Z for information on which certification codes are eligible for FEFP funding.
- Calculation is <u>completed by the Department of</u> <u>Education</u> based on reported data elements.



## FEFP – Allocation and Expenditure Requirements for funds received from this calculation

- Each district must allocate at least 80 percent of the funds provided for industry certification, in accordance with this paragraph, to the program that generated the funds.
- This allocation may not be used to supplant funds provided for basic operation of the program.



# FEFP – Allocation and Expenditure Requirements for funds received from this calculation (Teacher Bonuses)

- Districts are required to pay bonuses to each classroom teacher who provided direct instruction toward the attainment of an industry certification that qualified for additional full-time equivalent membership.
  - Bonuses are awarded to teachers who are employed by the district in the year in which the additional FTE membership calculation is included in the calculation
  - Districts must determine which teachers qualify for the teacher bonus under the statute.



# FEFP – Allocation and Expenditure Requirements for funds received from this calculation (Teacher Bonuses)

 The following bonuses are required from the funds in the 2019-20 FEFP Calculation:

Funding Weight on the 18-19 ICFL	Required Teacher Bonus in 2019-20
0.1 Weight	\$25
0.2 Weight	\$50
0.3 Weight	\$75
0.5 Weight	\$100
1.0 Weight	\$100

There is no cap for teacher bonuses.



## FEFP (Teacher Bonuses) – Additional Compensation Type Elements

- Teacher bonus information must be recorded in the Staff Information System
  - Additional Compensation Type element (Code 4)
    - Recorded on Surveys 2 and 3 for scheduled bonuses
  - Additional Compensation Type/Value element (Code 4 followed by 7-digit bonus figure which includes two decimal places)
    - Recorded on Survey 5 for paid bonuses
    - Example: \$450.00 = 40045000



#### **Test Administration Procedures**

- Industry certifications that are not administered in accordance with <u>Rule 6A-6.0573</u> cannot be reported for funding or any other purpose.
- Requirements include
  - Exam must not have been administered more than 3 times during the academic year.
  - A minimum of 20 days are required between test administrations.

# F71297 Amendments (implemented beginning with the 2018-19 FEFP)

- District Pro-rated FTE = Indicator if the student was subject to a pro-ration because the same certification was reported for funding in more than one district in the same year.
  - 1 when reported by just one district; 2 when reported by two districts;
     3+ (or more: number will be the number of districts that reported the same certification)
- Capped FTE = Indicator if grade k-8 student level cap of 0.1 FTE was applied
  - Y for yes; N for no (all grade 9-12 records will automatically be N)
  - Would only apply if student grade level was less than 9th grade
- Pro-rated FTE Value
  - If Student Level Funding Cap was applied
  - Calculated by multiplying the "Estimated Proportionate Share of Funding Weight" by 0.1 FTE

# Why wasn't this funded???



- 1) Industry Certification record is created locally but not sent to FLDOE.
- 2) Industry Certification record received reject errors causing the record not to load to FLDOE.
- 3) Industry Certification Outcome on the Industry Certification record does NOT have passing outcome.
- 4) Industry Certification Identifier on the Industry Certification record has an Identifier that is NOT funding eligible.
- 5) The Industry Certification record does NOT match the district's registered Career-Themed Course Registration. (This does not apply to Digital Tool Certifications.)
- 6) The Industry Certification Identifier was funded previously for the student.



- 1) Industry Certification record is created locally but not sent to FLDOE.
  - Aren't sure? Request O-File F71433O and verify it contains the number of records you expect; check specific schools, certifications and students
- 2) Industry Certification record received reject errors causing the record not to load to FLDOE.
  - Always check the Initial or Batch Edit Listing following each file submission. The edit listing is system generated automatically after each submission. You do not need to request the report: DPSdd.GQ.F71435.Yyyyy5
- 3) Industry Certification Outcome on the Industry Certification record does NOT have passing outcome.
  - The outcome must be code "P" to be eligible for funding



- Industry Certification Identifier on the Industry Certification record has an Identifier that is NOT funding eligible.
  - Check PK-12 Appendix Z (the appendix year should be the same as the data reporting year). The column "Additional FTE Eligible under S.1011.62(1)(o), F.S." must be Yes in order to be eligible for funding
  - If the certification was earned through dual enrollment with a district postsecondary institution or the Florida College System: Check the Postsecondary Industry Certification Funding List. The column "Eligible for District Performance Incentive Funds" must be Yes in order to be eligible for funding for districts; or column "Eligible for College Performance Incentive Funds" must be Yes to be eligible funding for colleges.



- 5) The Industry Certification record does NOT match the district's registered Career-Themed Course Registration.
  - Check PK-12 Appendix FF (the appendix year should be the same as the data reporting year). All 3 of these fields (school number, course number & industry certification identifier) must match on Appendix FF to be eligible for funding.



- 6) The Industry Certification Identifier was funded previously for the student.
  - A student cannot be funded for a specific certification more than once;
  - The historical F71297 reports contain all information needed to verify when/if a student was previously funded
  - Save all F71297 reports; they can be searched to see if the student/certification was funded in any previous year
  - If the student/certification was funded previously, they cannot be funded again even if you reported everything correctly in the current reporting year
  - Download the F71297 report as soon as possible, as it is available for a limited time



# Recommendation: Work with your District CTE Leadership on Reviewing Rejected Records

- Provide your district CTE director with the following information on the industry certification records:
  - Rejected Records with information on which edit was an issue.
  - F71082 report
  - F71432 report



# Best Practices for Ensuring 19-20 Industry Certifications are Funded in the 20-21 FEFP

- 1. Load Industry Certification Data by July 24, 2020 (Due date for the format).
- Run the F71415 report to validate funding eligibility of records.
- Share report with your CTE Director, who will be able to review and identify discrepancies with Career-themed Course registration and industry certification records.
- 4. From August 1 to August 10, district can update CTC registration for Appendix FF.
- 5. Submit edits by Survey 5 deadline (October 31, 2020).
