What is FETPIP? Florida Education and Training Placement Information Program

- A data collection and consumer reporting system established by Florida Statutes Section 1008.39 to provide follow-up data on former students and program participants who have graduated, exited or completed a public education or training program within the state of Florida.
- The information collected is for the purpose of evaluating and improving public programs, and for improving services to individuals who have been placed after participating in a workforce training program.

# FETPIP Training Relatedness Application

- The FETPIP Training Relatedness application automates many tasks for local education agency follow-up specialists/coordinators in the evaluation of Florida Education & Training Placement Information Program (FETPIP) follow-up data. The primary responsibility of the user is to make training relatedness decisions on former vocational program participant outcomes where FETPIP data does not show positive placement.
- The continuing education and Program/Industry relatedness data added by FETPIP should not be modified. FETPIP cannot provide military outcomes, but you can supplement military outcome data.
- Records in the same program with the same industry and occupation are unduplicated by FETPIP. For example, if there are nine people in nursing working in the health industry with an occupational title of Nurse, only one record is provided in the file used for evaluation. Following evaluation of unique program/industry occurrences, the duplicated file is updated with the appropriate training related decision as determined locally.



# FETPIP Training Relatedness Application

- Training Relatedness Decisions List Displays data by program, industry, and training relatedness code. The report is useful in reviewing training relatedness decisions. Use the arrow buttons to move between pages within the report. To export the report, choose the format you desire from the drop-down box and click Export.
- Programs Outcome by Individuals Displays data by program, by decision, and by student. Incorporates the decisions made by local coordinators and FETPIP outcomes to categorize each Exiter's placement by Program.
- Special Population Outcomes Provides a summary of outcomes for special population students who are classified as disabled or disadvantaged. Displays training related percentages by program, termination code, and training relatedness category.
- Summary of Programs Outcomes An aggregate report that displays training related percentages by program, termination code, and training relatedness category.
