- What is Data Governance?
 - A Set of principles and practices that ensure quality through the complete lifecycle of your data

The Wild West



- Before Data Governance, Information Services owned all the data!
 - IS was responsible for knowing and implementing all Business Cases while working in a silo
 - Departments would request changes to data fields they had no ownership

Departments and Schools did not correct data on a timely fashion

Getting to Know the Players

- Get to Know Your Stakeholders
 - Meet with each stakeholder
 - Find out what the stakeholder data concerns
 - Develop a relationship with each stakeholder, make them your business partner

- Stakeholders should be decision makers
- Meetings should have all stakeholders co-located
 - If not use video conference tools, such as MS TEAMS or WebEx

Meeting should be held on a regular basis: Minimally 2 x month

 - Business Process Owner List
 - Associates district leaders to process ownership
 - Data Management Calendar
 - Will list all major yearly milestones that occur from year to year
 - Change Control Meetings
 - Will inform related parties of changes and interruptions your main systems


