Shawna Reid: Now to speak of the keyword searching. It is an integral part of this system in combination with geo fencing, which will also talk about and those two items are the core of how this system works.

Shawna Reid: Next we have geo fencing, which I also mentioned was a core component of the social media monitoring tool.

Shawna Reid: OK, so the Florida school safety portal again provides real time access to information, but it doesn't mean that the data sets are real time.

Shawna Reid: So, for example, sensor information is collected by survey, that's not necessarily real time data, but you have real time access to that data. So that's an important distinction.

Shawna Reid: The users of the system that are accessing criminal justice data will only be able to access it via the portal and they have to already be authorized to access law enforcement information. So we'll talk about that in a little in a little bit.
