Famis Florida3: Also, we have a secure system, so all of this information is available to the districts, all this information is secure and only accessible by the district's.

Famis Florida3: And so list out a couple of the main sites that you all are familiar with Those are some of the sites that it monitors but it's in monitors quite a bit not only social media sites, but forums customer reviews anything that's publicly available on the web, it is searching.

Famis Florida3: So let me give you all a glimpse into how it works so there's keywords and then there's geolocation so like express to you before the keywords in the geo locations are core to how this tool works.
