MCKAY PREPAYMENT VERIFICATION - REJECT RULES

DELETED FOR 2022-23 ***ALL EDITS***

 District Number, Current Enrollment must be numeric, in the range 01-68 or 71-75 and must be correct for the district submitting the data. -record rejected-

EXAMPLE

The first two records listed below would be loaded to the database assuming no other reject rule would cause their rejection. The third record would be rejected since the District Number, Current Enrollment is not in the appropriate range. The fourth record would be rejected if district 01 submitted the record.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the database, the district must correct District Number. Current Enrollment and resubmit the records.

Database Reporting 2021-2022 Update

- Course Grades/Survey 4 reporting
 - Student Course Schedule Edit #2H revised
 - Database Manual Update May 13, 2022
 - 2H. If Survey Period = 4 and
 - School Number, Current Instruction/Service = 7001, 7004, 7006 or 7023;
 - or if District Number, Current Instruction/Service = 71 and School Number, Current Instruction/Service = 0300, 0400 or 0801;
 - or School Number, Current Instruction/Service has a Charter School Status other than Z and School Function/Setting equals V on the Master School Identification file.
 - or Location of Student equals T; and District Number, Current Instruction equals 01-68 or 72-75; and School Number, Current Instruction does not equal 7001, 7004, 7006, or 7023;

then Course Grade must not equal IP. -record rejected-

 Per the 2021-2022 FTE General Instructions, guidance in Appendix E (Database Reporting Requirements for Virtual School Students) ...

All virtual courses where students are enrolled for more than 14 days in a course should be reported in Survey 4 for completion rate purposes, but FTE Reported, Course greater than 0.0000 should only be reported for those courses in which the student had successful completions as described in the first section Appendix E.

GEFE (F62801) report versus GQUH (F71251) report

(Student Demographic Information format; Lunch Status data element #146025)
GEFE: Lunch Status Data by Programs/GQUH: Title I Public School Eligibility Survey Data

- Both reports display Lunch Status data by programs. (Programs: Eligibility by Survey Application/Provision 2/CEP)
- GEFE report displays Lunch Status data for all students.
- GQUH report displays Lunch Status data for students ages 5-17.

Student Attendance reporting

(Prior School Status/Student Attendance format; Days Present Annual (#113225) and Days Absent, Annual (#112025))

Report available for districts to download and review:

F70488 Student Average Attendance/Membership

Particular attention should be given to schools where "% Present" is 100
percent or less than 85 percent, as well where the "Days Absent" column shows
"0."
