

#### **Apprenticeship Overview**

- Under the leadership of Governor Ron DeSantis, Florida has invested over \$8.5 billion in state dollars for workforce education programs, making Florida number one in the nation for attracting and developing a skilled workforce.
- Apprenticeship and preapprenticeship programs are prioritized workforce training models that address the skilled-workforce shortage in any Florida industry.
- The Apprentice Florida campaign and initiative is dedicated to expanding apprenticeship opportunities throughout the state.
  - Over \$65 million have been invested in the Pathways to Career Opportunities Grant (PCOG).
  - \$5 million of PCOG funds have been allocated to the "Grow Your Own Teacher Grant" to expand teacher apprenticeship programs in Florida.
- This has increased accountability and data reporting required to measure registered apprenticeship and preapprenticeship program outcomes and successes.

# §446.032 - General Duties of the Department for Apprenticeship Training

§446.032 General duties of the department for apprenticeship training.—The department shall:

(1) Establish uniform minimum standards and policies governing apprenticeship and preapprenticeship programs and agreements which must require training providers to submit data necessary to determine program performance consistent with state and federal law. The standards and policies shall govern the terms and conditions of the apprentice's employment and training, including the quality training of the apprentice for, but not limited to, such matters as ratios of apprentices to journeyworkers, safety, related instruction and on-the-job training; but these standards and policies may not include rules, standards, or guidelines that require the use of apprentices and job trainees on state, county, or municipal contracts. The department shall adopt rules necessary to administer the standards and policies.





# §446.032 - General Duties of the Department for Apprenticeship Training

§446.032 General duties of the department for apprenticeship training.—The department shall:

- (2) By September 1 of each year, publish an annual report on apprenticeship and preapprenticeship programs. The report must be published on the department's website and, at a minimum, include all of the following:
  - (a) A list of registered apprenticeship and preapprenticeship programs, sorted by local educational agency, as defined in s. 1004.02(18), and apprenticeship sponsor, under s. 446.071.
  - (b) A detailed summary of each local educational agency's expenditure of funds for apprenticeship and preapprenticeship programs, including:
    - 1. The total amount of funds received for apprenticeship and preapprenticeship programs.
    - 2. The total amount of funds allocated by training provider, program, and occupation.
    - 3. The total amount of funds expended for administrative costs by training provider, program, and occupation.



# §446.032 - General Duties of the Department for Apprenticeship Training

- 4. The total amount of funds expended for instructional costs by training provider, program, and occupation.
- (c) The number of apprentices and preapprentices per trade and occupation.
- (d) The percentage of apprentices and preapprentices who complete their respective programs in the appropriate timeframe.
- (e) Information and resources related to applications for new apprenticeship programs and technical assistance and requirements for potential applicants.
- (f) Documentation of activities conducted by the department to promote apprenticeship and preapprenticeship programs through public engagement, community-based partnerships, and other initiatives and the outcomes of such activities and their impact on establishing or expanding apprenticeship and preapprenticeship programs.
- (g) Retention and completion rates of participants disaggregated by training provider, program, and occupation.
- (h) Wage progression of participants as demonstrated by starting, exit, and postapprenticeship wages at 1 and 5 years after participants exit the program.



### §1011.802 - Florida Pathways to Career Opportunities Grant Program

§1011.802 Florida Pathways to Career Opportunities Grant Program.—

- (4) The department shall annually report on its website:
  - (a) The number of programs funded and represented throughout the state under this section.
  - (b) Retention, completion and employment rates, categorized by program and provider.
  - (c) Starting and ending salaries, as categorized by program and provider, for participants who complete the program.





## Rule 6A-23.011 Program Performance Standards

#### 6A-23.011 Program Performance Standards.

- (1) Every registered apprenticeship program must have at least one (1) registered apprentice, except for the following specified periods of time, which may not exceed one (1) year:
  - (a) Between the date when a program is registered and the date of registration for its first apprentice(s); or
  - (b) Between the date that a program graduates an apprentice and the date of registration for the next apprentice(s) in the program.
- (2) The Department must evaluate performance of registered apprenticeship programs. The tools and factors to be used must include, but are not limited to, the following:
  - (a) Quality assurance assessments;
  - (b) Equal Employment Opportunity (EEO) Compliance Reviews;
  - (c) Retention rates. Completion rates and Wage progression metrics;
  - (d) Adherence to the approved program standards; and
  - (e) Compliance with rules relating to apprenticeship programs established in Chapter 6A-23, F.A.C.





## Rule 6A-23.011 Program Performance Standards

- (3) Accountability Reporting for Registered Apprenticeship and Preapprenticeship Programs. The Department shall calculate and publish retention rates, completion rates and wage progression metrics annually for all registered apprenticeship and preapprenticeship programs based upon the registered sponsor, program and occupation.
  - (a) Retention rate will be calculated as the percentage of apprentices or preapprentices retained or completing a program by the end of fourth quarter after the initial quarter of enrollment in a registered apprenticeship or preapprentieship program.
  - (b) Completion rate will be calculated as the percentage of apprentices or preapprentices completing the registered apprenticeship or preapprenticeship program within one (1) year after the expected program length identified in the program standards.
  - (c) Wage progression of participants will be calculated by registered program sponsor and occupation for the following periods: starting wage as identified in the current program standards, exit wage as identified by the wage scale for the last year in the current program standards, and post-apprenticeship completion wages calculated at one (1) and five (5) years after program exit based upon annual cohorts of program completers who are tracked using administrative records of employment and wages that are available to the Department.

## Rule 6A-23.011 Program Performance Standards

- (4) The Department must review a program's completion rates in comparison to the national average for completion rates. Based on the review, the Department must provide technical assistance to programs with completion rates lower than the national average.
- (5) Cancellation of apprenticeship agreements during the probationary period will not have an adverse impact on a sponsor's completion rate.



#### Secondary Data Reporting Guidance

- Establish and maintain a working relationship with your preapprenticeship program sponsors, if not your agency.
  - The data that the sponsor submits on the Preapprenticeship Data Collection Template is used to demonstrate program outcomes.
- If a student is enrolled in any apprenticeship or preapprenticeship course, there
  must be an associated apprenticeship sponsor code reported along with the
  course number
- Speak with respective agency CTE Director to learn of all preapprenticeship programs offered within agency high schools, including those that use a non-apprenticeship course number delivery method.
- Report all preapprenticeship activity.











#### Memo on Preapprenticeship Data Reporting

- In February 2023, the Department rolled out a plan to centralize data collection on preapprentices.
- Historically, preapprenticeship enrollment has been tracked and maintained regionally by each Apprenticeship Training Representative.
- Through this initiative, data collection will be standardized to enable accurate reporting on retention, completion, and tracking of preapprentices into Registered Apprenticeship Programs in accordance with section 446.032, Florida Statutes (F.S.).
- Outcomes are required to be published in Florida's Annual Apprenticeship and Preapprenticeship Report.
- Currently, there is neither a method of reporting on preapprenticeship within RAPIDS, nor does the Department have a case management software solution for the collection of this information.
- The Department requests Registered Preapprenticeship Program sponsors to provide this data on a biannual basis using supplemental data reporting to the state using Excel.





# Preapprenticeship Reporting Deadlines for the 2023-2024 Program Year

- Friday, April 26, 2024
  - Report on all preapprentices registered at any time between July 1, 2023, and present.
- Friday, July 12, 2024
  - Report updates that have occurred through June 30, 2024, including registrations, completions and cancellations.










### Preapprenticeship Agreement Form

## Importance of Social Security Number for Progress Tracking

#### 1008.386 Florida Student Identification

- (1) When a student enrolls in a public school in this state, the district school board shall request that the student provide his or her social security number and shall indicate whether the student identification number assigned to the student is a social security number. A student satisfies this requirement by presenting his or her social security card or a copy of the card to a school enrollment official. However, a student is not required to provide his or her social security number as a condition for enrollment or graduation. The Commissioner of Education shall assist school districts with the assignment of student identification numbers to avoid duplication of any student identification number.
- (2) The department shall establish a process for assigning a Florida student identification number to each student in the state, at which time a school district may not use social security numbers as student identification numbers in its management information systems.

#### Florida Education Identifier Assignment

• The Department has procedures for the assignment of Florida Education Identifiers as specified in Rule 6A-1.00141, Florida Administrative Code (F.A.C.).







  - Reporting will now be a 'Y' for the student is participating in career and professional academy which is a research-based program that integrates a rigorous academic curriculum with an industry-specific curriculum aligned directly to priority workforce needs established by the local workforce development board or the Florida Department of Commerce; or
  - 'N' for the student is not a participant in a career and professional academy.
- Districts will no longer need to register academies and Appendix Y will no longer exist and will not be needed for reporting.
- The division will send out a survey in the fall of 2024 to collect information on academies.

## Career Dual Enrollment (0.08 FTE) Process/List

- For the 2024-25 FEFP, a new additional student membership category of 0.08 full-time equivalent (FTE) for each student who completes a career course through the dual enrollment program with a grade of "A" in a pathway that leads to an earned industry certification included on the CAPE Industry Certification Funding List was created.
- Updates have been made to the <u>Student Additional Funding format</u> in Survey 5 of 2023-24 for district reporting on this FTE.

### 0.3 FTE for Career Pathways Completion

- Language on the 0.3 pathway funding was added to s.1011.62(1)(o), F.S., because
  of SB 240.
  - s. 1011.62(1)(o)c., F.S. "A value of 0.3 full-time equivalent student membership shall be calculated for student completion of at least three courses and an industry certification in a single career and technical education program or program of study."
- Section (11) of rule 6A-6.0576, F.A.C. outlines the conditions of the FEFP calculation for the 0.3 FTE including documents and reporting needed for the calculation.
  - Additional FTE membership will be calculated for each student who completed three courses in program and earned at least one certification linked to the program.
  - A certification may only be used to satisfy the requirements for one career and technical education program or program of study.





## 0.3 FTE for Career Pathways Completion Continued

- The following documents adopted in rule 6A-6.0576, F.A.C. will be used to identify eligible programs and programs to certification linkages for the calculation:
  - "Secondary Career and Technical Education Programs and Associated Courses with Dual Enrollment Course Substitutions, 2023-24"
    - This list consists dual enrollment course substitutions that have been identified for secondary a secondary CTE program. These linkages can be used as a substitution for one of the course sequences in a secondary CTE program.
  - "Secondary Career and Technical Education Program to Industry Certification Linkage List, 2023-24."
    - This list consists of secondary CTE career preoperatory, technical education and apprenticeship programs and identified CAPE K-12 FEFP funding eligible certification linkages.





## 0.3 FTE for Career Pathways Completion Continued

- School districts must report information in the following manner for use in this calculation:
  - Career and technical education courses must be reported on the Student Transcript
     Course Information format with reported credit earned in the course greater than zero.
  - The student must be reported in a career and technical education program or program of study on the Career and Technical Education Student Course Schedule.
  - The student must be reported with an industry certification on the Industry Certification format.
- The district in which the student was enrolled at the time of completing the third course or more shall generate the funding.
  - Funds shall be pro-rated among districts if more than one district awarded credit toward the third or more course requirement during the academic year.

## Top 6 Reasons Why Certifications Don't Get Funded

- 1. Industry Certification record is created locally but not sent to FDOE.
- 2. Industry Certification record received reject errors causing the record not to load to FDOE.
- Industry Certification Outcome on the Industry Certification record does NOT have passing outcome.
- Industry Certification Identifier on the Industry Certification record has an identifier that is NOT funding eligible.
- The Industry Certification record does NOT match the district's registered Career-Themed Course Registration.
- 6. The Industry Certification Identifier was funded previously for the student.





## Reports for Reviewing Records Industry Certification Data and Rejected Records

- CTE district staff should request the following F series reports from MIS staff to review industry certification records:
  - F71435 Rejected records with information on which edit was an issue.
  - F71082 Number of Students Who Took/Passed an Industry Certification By School, Industry.
  - F71432 Funding-Eligible Number of Students Who Took/Passed an Industry Certification By School, Course and Industry Certification.
  - F71415 This on-demand report can be used to estimate funding. Prior to the release of the F71297. In order to make use of this report, data must have been reported on the Industry Certification format.
  - F71535 This district on-demand report can be used to check for industry certifications that have been reported by the district but are not being funded. To make use of this report, districts must submit data by the load date.





## F71535 – On Demand Report on Why Certifications Are Not Being Funded

- This district on-demand report can be used to check for industry certifications that have been reported by the district but are not being funded.
- To make the best use of this report, districts must submit data by the load date.
- This report can be used to determine if updates to the registered careerthemed courses need to be made during the final registration window, which is held July 15<sup>th</sup> through the end of August.





## F71535 – On Demand Report on Why Certifications Are Not Being Funded Continued

- Includes District of Instruction, FLEID, First Name, Last Name, Industry Certification ID, Certification
  Title, Funding Weight, School of Instruction, Course Number, Course Year, Grade level and the
  following indicators:
  - Is the course on Appendix FF? Y or N.
  - Is the course on Appendix FF with the certification? Y or N. Could be X if a prior year certificate from 1718 or earlier is submitted.
  - Was this certification funded in a prior year? Y or N.
  - If funded in a prior year, in what district? District number (or NA if not funded).
  - o If funded in a prior year, in what year? Year (or 9999 if not funded).
  - o Is this certification a current year bundled cert? Y or N.
  - o Is this certification a bundled cert where a similar certification was funded in a prior year? Y or N.
  - o If a bunded cert was funded in a prior year, what district? District number (or NA if not funded).
  - If a bundled cert was funded in a prior year, in what year? Year (or 9999 if not funded).





### What is not covered on the F71535

- Certain basic criteria are not checked:
  - The certification record should have a matching student demographic record.
  - The certification record should be in an appropriate grade.
  - The certification record should have the appropriate FTE Type found in the Certification ID table.
  - The certification record should indicate that the student passed the test.
  - The criteria for Cape Innovation courses.
- Certain dual enrollment criteria are not checked. Districts should continue to ask for help determining lack of eligibility for dual enrollment certifications.


