- A. Teacher Class Roster public posting
  - a. Louisiana public teacher rosters, by class rolls will move also to posting of gains also textbooks & vendor impact success. Key point teacher of record/acc???
  - b. EOC Exams 30% minimum requirements- how this relates to course grade, what type score, validity resources (SS, critical content & criteria basis ??)
- B. ESE Portal version 2.0 now out (greatly enhanced & stable & internal HELP for users)
  - a. 18 school districts, 47,000 users
  - b. 71K+ IEPs; 6100 EPs; 15,000 matrices; prior written notices; meeting notices; progress reports,
    2 million page hits
  - c. Progress report options extremely popular; student dashboard
  - d. District ESE leadership and users in part dictate changes; very intuitive
  - e. Really savvy, highly interactive users
  - f. State offers Help Desk services; district user conference calls; buddy-system across veteran/new district users; no charge for districts use
  - g. Classroom, school, district & "power-user" options
  - h. Tech requirements 0 standard, regular DOE survey formats: teacher course; student course; student demographics; staff demographics & staff login; highly secure: works off MS Active Directory Services (ADFS)
  - i. First step: district ESE director & district tech conference with DOE/PEER Project staff
  - j. Logs access & users; provides management reports
  - k. Works with virtual schools and courses; school within a school
- C. Sunshine Connection tools & resources high quality & systems for teachers & school districts use WORTH INVESTIGATING FOR LCS
  - a. Accommodates charter schools (as of fall 2010)
  - b. Does new year rollovers, archiving
  - c. Systems is FAST 40MB, uploads < 5 seconds
  - d. Online identity management (includes new account formation on demand 24x7; on demand password reminders or updates

- D. SIS Changes relatively few; no new formats (for a change); Excel formats on web with specific changes updated yesterday
  - a. Survey 6 & 8 split into two: 6 = student membership (student demo) & FACTS.org Sept 3 & 17<sup>th</sup>;
    8 = PMRN, July 29 Sept 23<sup>rd</sup>
  - b. 3 formats have added elements
    - DJJ entry & exit deleted SS test scores, GS only

- F. Charter schools data break-out since there is limited LEA control over data quality
  - a. Course code HQT flag must be populated & CCD needs to be approved sooner; rules process
    - Certification codes are still not consistent, Crosswalk is not adequate, changes are made at anytime, teacher certification
    - \*recommendation from Steering Committee to get earlier and consistent CC information - it's a class size
- G. FASTER all districts must participate & enforcement is needed & recommended from SC;
  - Statute change prior year & historical records must also be spelled out
  - Jackie Johnson
  - Must have elementary
  - Teeth needed, penalty or credit only way
  - SHOTS support
- H. IT Auditing AG office, IT Audit Division
  - a. IT & Financial/FEFP & Operational & Quality Assessment Reviews
  - b. Frequency 3 yrs
    - < 150,000 Annual Financial
    - > 150,000 (24) audited every 3 years
  - c. Risk assessment: because of critical dependence on IT, operational audits of IT are part of QA, Financial, FEFP & IT audits. Emphasis on controls.
  - d. JR participation in change management CR
  - e. Dale security incident documentation & data study
  - f. 1 SACA membership

AUDIT security officer, staff training & on-going awareness, AUP, vendor/3<sup>rd</sup> part, most critical applications-user authentication, change management, access criteria, critical transaction monitoring logging, user ID process/passwords; user account profile logs, data management security; written policies on access authorizations, transmission, storage, physical environmental controls; restoration & recovery, written approved & tested disaster recovery, vulnerability scan, security incident logging ???
