



The database serves as the rostering tool and repository for the scores from the Florida Assessments for Instruction in Reading (FAIR) - Florida's K-2 and 3-12 reading screeners - as well as the scores and observations from the Florida Kindergarten Readiness Screeners (FLKRS), to include FAIR and Early Childhood Observation System™ (ECHOS[™]). This presentation will review the process for using Survey 8 to roster the Progress Monitoring and Reporting Network (PMRN). Survey 8 requires the submission of both the FLDOE's Student Demographic Information and Staff Demographic Information formats through the Automated Student Information System. The presentation is geared towards those individuals not familiar with the submission and rostering processes. **Room 205** Transportation Reporting **Reporting Transported Students for FEFP** Charlie Hood - DOE How do we get from Point A (students getting on the bus) to Point Z (receiving your fair share of the FEFP funds)? It's a complex equation that requires informed teamwork from the bus driver on up. This workshop will address the importance of all three programs—Transportation, Finance, and Information Services—working together on the state and local level to ensure accuracy and timeliness throughout the process. We'll cover the basics of student transportation as a component of the FEFP, as well as some current hot topics and FAQs.






FSU Turnbull Conference Center Floor Plan
